The photographic retail business I founded in 2013 called imagex in Sheep Street, Bicester, has ceased trading

I departed the business in March 2017 following repeated disagreements with my two ex-Jessops partners over proposals for the future growth and development of the business, and our Partnership Agreement didn't allow for any other solution to our internal disputes

The business I left behind at my departure was successful, profitable, free of any debts or borrowings, and all the original investors who had helped us get started had been fully repaid

As many of you know, since the closure of imagex in mid-March, I have been seeking to secure a new lease on the premises from the landlords and re-open a new version of the business with a new team, new funding, a new-look store and many great plans

However, I am now very sorry to report that despite my best efforts, the landlords have not agreed to any of my proposals to allow my return to their business premises and launch this new venture in this location

*The good news is :* I am now working on plans to launch the new imagex in a new location - more about this to follow

*The bad news is :* I will not be able to assist suppliers or customers of the previous imagex with securing any personal items or stock that they were hoping to retrieve from the premises

This letter is therefore to assist suppliers and customers with their dealings with the owners of the premises for the previous imagex
